

# European Entrepreneurship Experience Study Abroad in the Heart of Europe



## Application

The enclosed forms must be completed before the European Entrepreneurship Experience Study Abroad Program can begin to process your application. Applications are due now.

If places are available after the regular application deadline, we will continue to accept them, (travel arrangements permitting) but the participant needs to realize that places in this program will be limited to 20 and will be available on a first-come, first-served basis. We encourage early application to ensure the best possible chance of participation. Please type this application if possible.

#### **Main Application Form**

The information requested on this form is very important; please be sure to complete all of the questions asked as thoroughly as possible. This information will help us in making the best arrangements for you. It is especially important for us to have accurate addresses and telephone numbers, and to know the dates that you will be available at each.

#### **Applicant's Statement**

This form must be signed by you and, if you are under 18 years of age, by your parent or guardian.

#### Insurance

All participants will be required to obtain temporary insurance through the Center for International Studies. More information will be provided before departure date.

#### **Transcript**

An unofficial copy of your latest transcript or degree audit is required. This should be sent along with your application.

#### **Passport**

You will need a valid passport if you are traveling overseas. Processing a passport can take 2 months or even more. Do not delay sending your application if you are waiting for a passport, but make sure we know that you are obtaining one. No visa is required for American students traveling with a U.S. passport. If you are traveling with a non-US passport, be sure to check the travel requirements for your particular passport at <a href="http://www.immihelp.com/visas/schengenvisa/requirements-exemptions.html">http://www.immihelp.com/visas/schengenvisa/requirements-exemptions.html</a>. If your country is on this list, you will need to apply for a Schengen Visa. #### Fees

A \$500 non-refundable deposit must accompany your application and should be turned in as early as possible. Once you are accepted to the program, the deposit is applied to your program fees. The first payment of \$1400 is due by February 4, 2011, and the final payment of \$1400 will be due March 18, 2011.

Program fees are not refundable after the start of the program unless there is a medical emergency which is verified in writing from a medical authority, for which a partial refund may be due you.

### **Deadlines**

Completed applications are due as early as possible. If you apply later in the year, the cost could be affected by availability of travel and room arrangements. Again, early application is encouraged!

If your completed application is not turned in a timely fashion, your chances of being accepted will go down.

The European Entrepreneurship Experience Summer Study Abroad Program reserves the right to require the withdrawal of any participant for reasons of unacceptable personal behavior and/or inadequate academic participation (when applicable). Such dismissal will be without refund in program fees and expenses, and the student being dismissed will be responsible for the additional expense for the trip back home.

There are some basic and inviolable rules of behavior related to every program.

- 1. The student must maintain an adequate standard of academic work in programs and behave responsibly at the host site and living situation.
- 2. The student will study under the direction of the Program Directors and must abide by the philosophy, structure and regulations of Baylor University.
- 3. Illegal drugs in any form are not tolerated, and students dependent on their use should not apply. Students in the program found using or possessing illegal drugs in any form are subject to immediate dismissal at participant's expense, without refund in program fees and expenses, and with the additional cost for the trip back home.

- 5. Sexual behavior disruptive to the program merits dismissal at participant's expense, without refund in program fees and expenses, and with the additional cost for the trip back home.
- 6. Breaches of the local law of the host community or country are referred to and handled by the appropriate law enforcement authorities (and will not be the responsibility of the Program Directors, the host University, or Baylor University).

NOTE: A student with a GPA lower than 2.75 may still apply, but he or she may be asked to provide additional information. Acceptance can be revoked if applicant becomes ineligible at any time before departure.
