<u>Date</u>	<u>Dividend</u>	<u>Price</u>	<u>Day</u>
8/31/2011	0.00	16.31	0
9/15/2011	0.15	16.08	15
12/22/2011	0.17	18.50	113
2/23/2012	0.17	19.31	176
6/21/2012	0.17	19.53	295
8/31/2012	0.00	20.71	366
